# **Bangladesh Institute of Labour Studies - BILS BILS/LO-FTF Project**

Report of Bridging Phase

(1 September 2011–31 January 2012)

## **Background**

BILS/LO-FTF Project (Decent Work and Poverty Reduction in Bangladesh) was designed to implement in two phases. The 1<sup>st</sup> phase has been implemented for the period of 15 March2009 – 31 August 2011 and the 2<sup>nd</sup> phase of the project have been started from 1 February 2012 and will be completed on 30 September 2014. Between the two phases there was a gap period of 5 months from September 2011 to January 2012 and during the period a bridging phase has been implemented. The main focus was to continue the regular activities of 1<sup>st</sup> phase i.e. child labour schools, training centers & motor workshop, publications and OHS house up to 2<sup>nd</sup> phase, which are also the regular activities of 2<sup>nd</sup> phase. Besides, some unimplemented activities of 1<sup>st</sup> phase and some activities for keeping the committees/networks developed in 1<sup>st</sup> phase in touch with the project were implemented during the bridging phase.

First the bridging phase approved for the period of September-December 2011, afterward the bridging phase extended for another one month no-cost extension due to delay in starting of 2<sup>nd</sup> phase. During the extension of the bridging phase only the regular activities of CLEP were implemented.

The planned activities of all sub-components have been implemented by BILS with active involvement of trade union activists and leaderships. The regular publication i.e. Bulletin, Journal has been published and distributed along with the Calendar & Diary of BILS fro the year of 2012. Under sub-component 2 a total of 72 child laborers have completed their basic skill training course and they have been awarded with certificates & tools/equipments.

Simultaneously, BILS contributed to review the new Labour Act-2006 and worked as workers group subcommittee of the tripartite review committee. During the bridging period, entrepreneurship activities and BILS network with different labour and social issues have also been continued.

# **Outputs and Impacts:**

- A training manual has be developed for youth volunteer.	The manual will be used by the youth volunteers to orient the root level activitists/workers on decent work, labour rights and labour law related issues.

- BILS's Bulletin (Bangla and English) and News Flash has been published and distributed along with the Calendar & Diary for 2012.

BILS associated NTUCs and the national-international stakeholders have been informed on the labour related issues happened during the bridging period.

 A total of 40 TU leaders of service sector and rice processing sector trainers have been informed on current labour issues and oriented on the 2<sup>nd</sup> phase activities of LO-FTF project. Through the meeting the leaders were in touch with the project that will be helpful to implement the  $2^{nd}$  phase of LO-FTF project.

 CLEP impact studies have been reviewed and a list of recommendations has been obtained to take future initiative on Child labour issue. The recommendation will contribute in implementing the BILS's Child Labour Elimination activities as well as to take future initiatives.

- A total of 144 teenagers Tongi and Keranigang centres have been continued their 12 months duration NFE course.

Significant number of child labour has been withdrawn from workplaces and enrolled in the NFE course. After completion of the NFE either they will be mainstreamed into formal education or will be enrolled into basic skill training

- A total of 144teenagers have been continued their 6 months duration BST course in 4 selected trades in Tongi and Keranigong centres. A Total of 72 teenagers from Tongi Centre have been completed their 6 month BST course and after completion of the courses, numbers of teenagers entered into job market or become self-employed.

After completion of the training the teenagers have entered into job market or have been self-employed, which brought positive impact in preventing and eliminating child labour.

- A total of 16 teenagers out of 24 have been continued one year duration apprenticeship training in BILS-Motor workshop. The teenagers will complete their 1 year apprenticeship training on motor mechanics on 30 April 2012 and they become able to compete in the job market.

- Area base committee of re-rolling mill and the ship breaking TU forum have continued their activities.

- The committees had been in touch with the project actives which will be helpful in the 2nd phase of BILS/LO-FTF project.

- As a focal point for service delivery to the metal workers, 'OHS House' has been continued the awareness raising campaign and capacity building activities.
- Capacity building and awareness raising activies of the OHS House have developed awarness of the workers in nthe shipbreaking sector, which will contribute in organizing the workers of Ship-breaking sector.
- A total of 15 orientation programmes has been conducted in Dhaka and Chittagong. Through the programmes, a total of 252 Re-rolling and Shipbreaking Workers have been knowledgeable on basic workers rights, minimum wage and occupational health and safety.
- A workforce, knowledgeable and aware on basic workers rights, minimum wage and OHS, will contribute in organising other workers in the sectors.
- Construction Sector Teams has been continued their activities and the progress have been documented
- The committees had been in touch with the project actives which will be helpful in the 2nd phase of BILS/LO-FTF project.
- The Common Minimum Demand (CMD) for construction workers have been advocated with City Corporation and RAJUK.
- Through the advocacy with related govt. authorities will be helpful to ensure the workers rights of construction sector.

#### **PROJECT DESIGN:**

The strategy and design of the bridging phase was the same as the 1<sup>st</sup> phase of the BILS/LO-FTF project (Decent Work and Poverty Reduction in Bangladesh). Like 1<sup>st</sup> phase there were 4 sub-components under the bridging phase and all the activities has been implemented through the participation of NTUCs, associated with BILS. Each sub-component has been implemented under the guidance of advisory committee formed for the sub-component. For each sub-component an advisory committees has been in the 1<sup>st</sup> phase of the BILS/LO-FTF project consisting the senior leadership of BILS, which continued in the bridging phase. The advisory committees have regularly monitored the project actives and provided their suggestions for the better implementation of the project.

The management structure and institutional framework of the bridging project was also same as the 1<sup>st</sup> phase of the BILS/LO-FTF project.

### **Major budget Revisions**

First the bridging phase approved for the period of Sep-Dec 2011 and the total budget was BDT **2,522,414** which equivalent to DKK **212,862**. Further the bridging phase extended for one month no-cost extension and the total budget was **2,731,474** which equivalents to DKK **214,233**, but due to exchange rate we have receive total BDT **2'890'376**. The budget for the four months bridging phase very limited, moreover one month no-cost extension made BILS very difficult to complete the activities of bridging phase.

### **INPUTS:**

The LO-FTF Council provided the financial and technical supports to implement the bridging phase. Inputs from the Kathmandu regional office of LO-FTF Council were very much supportive, which helped BILS to conduct the activities of bridging phase.

BILS has provided all administrative and management support to implement the activities of bridging phase. BILS associated NTUCs provided their support in implementing the project activities and BILS leadership provided their guidance through the project advisory committees.

## **ACTIVITIES:**

All the planned activities of the bridging phase has been completed successfully within the timeframe. The main activities were to continue the regular activities of BILS/LO-FTF project up to the 2nd phase of the project. Besides, some other activities including the predatory activities for 2nd phase have been implemented. The implemented activities were as follows;
