Editorial

Recently BILS has published a survey report on workplace situation 2017 on the basis of published news on National dailies regarding workplace accident, violence, industrial disputes and workers movement issues, which shows that 784 workers were died and 517 workers were injured in different cases, marks the sectors where workplace security of workers are not ensured and in which sectors workers are being victim of violence. At the beginning of the year, BILS has started to work with this issue by taking some necessary steps to reduce workplace accident. In line with this, on January, arranging roundtable on CSR, social justice and workers' welfare to ensure workers participation in Corporate Social Responsibility-CSR activities in Bangladesh was considered as an important issue. Organising Sarmik Nirapotta Forum Conference 2018 on January with the joint initiatives of human rights and labour movement aimed at establishing a culture of secured, decent and dignified job for all was another notable Issue. Besides, forming human chain and protest rally regarding workers killing, consultation meeting on forming labour solidarity forum, discussion meeting for setting minimum wage structure for RMG workers and several programmes were held during this period.

At present time, the role of women workers are not less than that of male workers, but in some cases their contribution in the economy are not recognized. Observing International Women Day 2018 at different places was considered as an important issue to stop torture, violence and to ensure fair wage, compensation and decent workplace for women.

We hope, in near future we will be able to achieve all relevant rights including the right to organise working people, fair wages along with workplace safety.

They said, the number of death in last year was 32 according to various news media sources. They also urged to protest workers death in construction sector.

Leaders said, "It is necessary to strengthen inspection system, security and protection at stone quarry immediately without any delay. Otherwise, risk and loss of lives of workers will continue to increase. Besides, they demanded fair investigation and taking necessary legal steps by local administration to implement Labour Law and responsible authorities of Department of

Inspection for Factories and Establishment. They also urged to the concerned people for identifying the responsible people including the employer and bringing them under the law and providing appropriate punishment, providing compensation to the injured workers along with taking steps for the implementation of Labour Law immediately to ensure the security of workers all over the country.

Speakers in the meeting said, due to the improper monitoring and vigilance of government department accidents and injuries are occurring every now and then. The vard owners are careless about improving the existing risky working environment. Moreover, there is absence of TU rights in the yards and the Labour Law is not functioning. So the accidents and deaths are rampant, the speakers claimed. They demanded implementation of minimum wage, workplace safety and TU rights in ship breaking sector. Beside, all the injured and dead workers should be given adequate compensation, added.

It is to be mentioned that on December 25 and 26, 2017 two workers Md. Manik of M S Trading and Md. Masum of Sagorica Ship Breaking yard died in fatal accidents. A total number of 19 ship breaking workers died in 2017 in various accidents.

Defining minimum wage at depermining sectors

Bangladesh government has taken initiatives to form minimum wage board as well as define minimum wage for workers at different sectors considering the living cost at present situation and improving their life standard. Regarding this, RMG, ship breaking, tannery, tailoring factory and glass, silicate sectors are mentioned areas.

New wage board formed defining minimum wage for RMG workers

Government has reformed a new wage board to define minimum wage for RMG workers. Besides, a report has to be submitted along with recommendations within six months, said State Minister of Ministry for Labour and Employment Md. Mujibul Haque,MP in a press conference after the meeting which was held on January 18, 2018 at Conference Hall in Ministry almed at defining the minimum wage at RMG sector.

Minimum wage for workers of ship breaking industry

Government has increased the minimum wage for the workers of ship breaking industry. In this case taka 16,000 has been defined as minimum wage instead of previous minimum wage taka four thousand and six hundred twenty five. An order was issued on February 11, 2018 from Ministry of Labour and Employment by declaring new minimum wage for workers at ship breaking industry. Dividing into four grade, taka 8,000 is defined as basic wage for the workers of last

grade. 16000 taka is defined as monthly wage of a worker including 4000 taka for house rent, 2500 taka for treatment and 1500 for conveyance whereas 615 taka will be fixed as their daily wage.

Minimum wage for tannery workers

The government has announced Tk 12,800 as the minimum monthly wage for the country's tannery workers with an increase by 46 per cent from the existing Tk 8,740.

The government took the initiative to review the wages for tannery workers in April last year by appointing the representatives from the owners and workers to the wage board as the wages of the sector's workers were last reviewed in 2011.

The minimum wage board has finalised its draft proposal for the tannery workers and Issued gazette on December 24, last year seeking, if there is any, written objections against or suggestions on the recommendation in 14 days. Later on, as no one had filed any objections or suggestions to the recommendations, the board sent its final recommendations to the labour ministry. In the wage structure, the government incorporated five grades for the workers while four grades were for the staff and employees.

The labour ministry through a gazette notification on February 27 announced that the minimum wage for workers in grade-5 at Tk 12,800 includes Tk 7,000 as basic

pay, Tk 4,200 as house rent, Tk 1,000 as medical allowance and Tk 600 as conveyance allowance.

The government also announced that the minimum wage for the workers in grade-5 and residing in Savar and divisional towns would be Tk 13,500 as they would get Tk 4,900 as house rent.

For grade-4 workers, the wage the ministry has set is Tk 15,710 as monthly gross pay for workers in divisional cities and Savar area and Tk 14,880 for workers in other areas.

Monthly minimum wages has been set at Tk 17,920 for grade-3 workers in divisional cities and Savar area and Tk 16,960 for workers in other areas.

For grade-2 workers, the ministry set Tk 21,150 as minimum monthly wage for divisional cities and Savar area and Tk 20,000 for other areas.

Workers in grade-1 at divisional cities and Savar area would get Tk 25,400 as monthly minimum wage while workers in other areas might get Tk 24,000 per month, the ministry gazette said.

Minimum wage for workers of tailoring factory

A new wage board for workers at tailoring factory has declared by Ministry of Labour and Employment on March 20, 2018. In this new structure, taka 4 thousand and 850 is defined as minimum wage which has increased 108 percent comparing with the wage structure in 2008. Dividing the workers into 5 grades, taka 4,850 is fixed as minimum wage.






517 workers were injured at workplace, among them 109 workers were women. Among these 158 workers in the largest number was in garments industry, 92 workers in construction sector, 48 workers in transport sector. Reason behind the accidents showed that 416 were occurred by road accident, 126 were occurred by electrocution, 59 incidents were happened by falling from height, 29 were occurred by fire accident and 25 were occurred by landslide.






In addition, 258 workers were killed and 120 workers were injured by violence which happened between January to December. 27 suicide case were happened and 27 workers were missing during this period.

In last year, 181 industrial disputed were occurred whereas 91 were in RMG sector, 36 were in transport sector, 7 were in Birl industry, 6 in agriculture sector and 5 disputed were occurred in each sector of water transport. Due wage, over time, compensation, factory closed without notice, workers retrenchment were the main reasons behind the industrial disputed. In this regard68 protests and 21 human chain were occurred. In addition, 18 strike, 15 road blocked, and 12 rally were happened.









In last year 56 disputes were caused by due wages, 35 were caused by rights and claims while 14 for lay off, 12 for workers beaten, 13 for workers repression, 6 for overtime and 5 for compensation.



The highest number of violence was occurred in transport sector which was 29% whereas domestic workers 9%, RMG sector 19%, security guard 11%, agriculture 12%, day labour 7% and others was 13%. In garment sector 39 workers were died whereas the number of domestic workers were 19, 58 in transport, 22 in security guard, 24 in agriculture, 14 day labour and 27 workers were died in other sectors.



Book review

Appreciating BILS role to prepare recommendations for Trade Union in CSR activities the State Minister said, "It is advisable to represent Trade Union in CSR policy formulation committee with the initiative of the ministry." He also said that CSR should be managed from net profit after fulfilling all the workers' demands.

Discussants in the roundtable said that transparency and accountability should be ensured in case of utilizing CSR activities for actual underprivileged workers. Defining CSR amount on the basis of business capital or investment distribution should be mandatory, they added. They emphasized on bringing CSR under the compulsory of legal framework. They also demanded to the organisations which are conducting CSR activities for maintaining a tripartite framework.

BBS Survey: Number of unemployed people increased after 13 lakh new jobs

Bangladesh Statistics Bureau (BBS) published a survey report on labour force of 2016-17 fiscal year on the basis of quarterly report. In the report it mentioned that, in last fiscal year, the number of newly employed people were 13 lakh while 6 lakh and 8 thousand people work in exchange for wages. Among them 4 crore 22 lakh are men and 1 crore and 86 lakh are women. According to the survey of BBS, the number of unemployed people has Increased. At the end of the fiscal year 2016-17, there are 26 lakh and 77 thousand people are unemployed all over the country. According to the International Labour Organisation (ILO) principle, people who get chance to work less than an hour in a week in return for wages are considered as unemployed.

According to the labour force survey, there are 6 crore 35 lakh working people at the age between 15 to 64 in the country who are always prepared for work. Regarding this, they are not included into labour force who are studying, sick or not prepare for work for any other reason.

Defining minimum wage (After Page 8)

and silicate industry workers in accordance with the labour act as the wages for the sector were last reviewed six years ago. Recently, the labour ministry has issued a gazette notification appointing the representatives from workers and owners to the wage board. The board would determine the wages considering the cost of living and the paying capacity of the factory owners.

Workplace Situation Report 2017

Bangladesh Institute of Labour Studies-BILS published a survey report on the basis of publishing news of 2017 in National dailies regarding workplace accident, violence, industrial unrest and workers movement issues.

According to the survey report 784 workers were died whereas 21 were women workers.

Conferring to the sector, most workers were killed in the transport sector where the number was 307. Besides, 131 workers in construction sector, 55 day labour, 34 agriculture workers, 24 electricians, 21 ship breaking workers, 21 in stone quarry, 20 in rice processing, 17 fishing workers and 16 workers in RMG sector were died.
