Speakers opined that, mostly informal sector workers of Chittagong are the victim of mismanagement and overall decent work scenario of this region is very worrying. Workers are every now and then being deprived of their basic rights. They are not getting proper wages, leave and other benefits. The job security is not always there. We have to come forward to protect the workers' rights-SSF member organisation representatives said.
