Workplace Situation Report 2019

Considering the workplace situation and labour market, BILS publishes a survey report on the basis of news published in different national newspapers regarding workers' unrest, violence

and workplace accident. Regarding this, analysing the workers condition at workplace in 2019, workers' unrest in RMG sector has become the crucial fact. We tried to highlight the issues in

Demands to ensure the rights of migrant workers

Joint Secretary General Dr. Wajedul Islam Khan moderate the programme. Ministry of expatriates and Expatriates' Welfare Additional Secretary Khadiza Begum was present as chief guest. Manusher Jonno Foundation Executive Director Shahin Anam present as a special guest and BILS Secretary General Nazrul Islam Khan delivered welcome speech. while Sramik Karmachari Oikva Parishad (SKOP) Joint Coordinator Naimul Ahsan Jewel, ILO Chief Technical Advisor Laetitia Weibel Roberts. Warbe Development Foundation Chairman Sved Saiful Hague, National Domestic Women Workers Union Advisor Abul Hossain, **BILS Executive Council Member Abdul** Wahed, Shakil Akhter Chowdhury, Umma Hasan Jhalmal, Pulak Ranjan Dhar, BLAST Deputy Director Adv. Soliderity **Borkat** Ali, Center Bangladesh Program Officer Adv. Nazrul Islam were present. SKOP affiliated and BILS associated national trade union federations leader. Working civil society organisation on Migration Workers, Govt. Official, Researcher, Private organisation and media personel were present at the program.

Speakers at a discussion said the government needs to recognise intermediaries, locally known as "dalal", by bringing changes to laws to accountable them for malpractices in the country's labour migration sector. They said intermediaries are mostly responsible for irregularities and high migration costs and their presence is rampant at different tiers of the recruitment process, but inadequate government initiatives have left them unaccountable.

Presenting a research paper, BILS Deputy Director (Research) Manirul Islam said that, International policy instruments are very broad on labour migration as well as have established comprehensive policy guidelines to address labour rights, human rights and women rights. Out of ten (10)

international policy instruments are reviewed, eight (8) have given particular emphasis to ensure just and favourable condition of work. At least, five (5) of the policy instruments have covered comprehensively the right to trade union. Protection of irregular migrants is also specified. A politically agreed comprehensive global governance framework to effectively address labour migration is though missing. Numerous conventions and recommendations are obtained internationally, but none of them is a bindina treaty. The status ratification of the international conventions/treaties is one of the lowest. The status of implementation of internationally agreed labour and human riahts is rather poor particularly in the Middle-Eastern labour receiving countries. Instead, they have developed their own system such as 'kafala system' to govern labour migrants in which workers mostly perform as bonded

labourers. As such, labour rights have to do so. gone a restricted one. The right to trade union exists only in paper and is never a practice.

Bangladesh is the sixth highest labour sending country in the world. Remittance earning is an essential contributor to the GDP. It was desirable that Bangladesh has a proactive and an ideal migration policy regime to follow. National migration policy regime is though reviewed followed reactive responses crisis management and incomplete comparatively disorganised. It is only in 2006 that the migration policy is formulated first. Until then, there were no defined set goal and target to act on and to achieve. It was basically an act (framed in British India in 1922) and an ordinance (came in force in 1982) driven control and governance of labour migration. A second new policy is formulated in 2016. This reportedly more comprehensive one. Apart from this, a number of supplementary Acts and Rules also are formulated and enacted onward Overseas 2006. The Employment and Migration Act 2013, the Prevention and Suppression of

Human Trafficking Act 2012, the Wage Earners Welfare Board Act 2018 and Overseas Employment Migration Management Rules 2017 are of them worth mentioning. Our review further suggests that there is persistent serious inconsistency and incoherence between and among different policy instruments. Mostly, Acts and Rules are formulated independently and followed the 1982's ordinance. Objectives and directives are set in the policies, not enough. Authority smart and accountability are not properly in most of the cases. 'Labour rights' is a poor focus. The 'right to TU' lost case. Policy/law implementation is rather poor.

Proper implementation of policies and agreements can end sufferings of female migrant workers, said BILS Secretary General Nazrul Islam Khan. He alleged those who are entitled to implement the laws lack the capacity

Laetitia Weibel Roberts, said her organisation has been providing technical support to the Bangladesh government to ensure safe and orderly migration.

Addressing the event as chief quest, Khadiza Begum said the ministry is committed to bringing changes in the laws and modernise those in the changing context of labour migration sector.

Presence of the intermediaries could be seen from rural areas to the offices of recruitment agents in Dhaka, said Israfil Alam, MP chairman Bangladesh National Parliamentarians' Migration Caucus on Development. However, they do not have any accountability. They neither exist in law nor do they abide by any code of conduct or policy, he said while chairing the discussion.

Israfil said although they repeatedly urged recruitment agents provide intermediaries with identity cards, the agents did not comply with such requests. "The government also failed to hold them accountable."



Industrial relations and workplace unrest

In 2019, a total number of 434 workplace unrest were occurred in different sectors. The highest number of unrest was occurred in RMG sector which was 134 and the reason behind the unrest was Due wage issue. 68 were occurred in Jute Mill sector, 61 were in Transport sector, 26 were Press and Media, 18 in Agriculture sector, 17 in Hawker, 15 were Water Transport Worker, 11 were Education sector, 9 were Tea Garden Worker, 9 were City Corporation and 66 others were occurred in others sector.



sector while 247 workers were injured and among them 184 workers were men and 63 were women worker. Moreover, the highest number of workers was injured in RMG sector due to unrest whereas 187. 124 were men and 63 were women workers. 40 workers were injured in Jute Mill and 20 were Injured in Electricity sector due to unrest in 2019.

According to the survey report 2019, 154 incidents were occurred placed demands. 108 were occurred rights and claim, 54 were occurred demanding due wages, 37 were occurred Due Wages and Allowance, 14 for Lay Off, 14 for Due Wages and Placed Demands, 8 were occurred for Workers Death, 5 were occurred for Factory Closure without Prior Notice and 35 for others issues.



Causes of Unrest


Workplace violence

According to the workplace survey report it is found that, in last year 1292 workers were victim of violence in different sectors, while 332 workers were death, 810 workers were injured, 67 workers were missing and 26 workers committed suicide.

The highest number of workers was victim in Migrant sector which was 578, in where 35 workers were death, 496 were injured, 1 suicide and not mentioned 46. The second highest number of workers was in RMG sector which was 126, in where 38 workers were murdered, 76 workers were injured and 5 worker was missing and 7 workers committed suicide. In Transport Sector 117 casualties were occurred whereas 83 workers were death, 17 workers were injured, 3 workers committed suicide and 6 workers were missing. In Fishing and Fisheries sector, 80 casualties were occurred in where 11 workers were murdered, 23 were injured, 46 were missing. 51 casualties were occurred in case of domestic workers whereas 17 domestic workers were death, 32 were injured and 1

Workplace accident and OHS

According to the survey report, 1200 workers were killed in workplace accident, while 1193 were men and 7 were women workers. Conferring to the other sector, the death toll was high in transport sector which was 516, whereas all of them were men. The second highest number was counted in construction sector, which was 134 and 133 are men and 1 were women worker. The third highest death toll, counted in agricultural sector, was 116. Apart from





time, 27 more workers were killed in different areas, where their sectors were not mentioned in newspapers.

Comparing the survey report with one of 2018, it has been found that in 2019 the numbers of death were not only high in transport sector like the previous year but also it was increased more than the previous year. In 2018, 424 workers were killed in transport sector which was 516 in the next year. Similarly, in construction sector 161 workers were killed in 2018 which was 134 in 2019. Workers in construction sector are not aware of their risk of life and the owners are not taking initiatives as well as providing

In last year, 695 workers were injured whereas 678 were men and 17 were women. In 2019, the highest number of workers was injured in Fishing and Fisheries sector which was 132 and the second highest number was in Construction sector which was 117. Besides, 104 Transport worker, 66 day labourer, 40 Agriculture worker, 30 RMG Worker, 28 Ship Breaking Worker, 22 Steel Mill Worker, 22 Water Transport Worker, 12 Plastic Factory Worker, 12 Railway worker.

78 workers were injured in other sector including, Security Guard, Jute Mill, Manufacturer Industry, Metal Factory, Paper Mill, Rice Mill, Re-rolling Mill, Stone Quarry, Media and NGO while 32 more workers were injured whereas their sectors were not identified.

In case of occupational health and hazard The number of sick in Industrial Unrest causes of hunger strike- 268 (Jute) and The number of death in Industrial Unrest causes of sickness in hunger strike- 2 (Jute).

This factory is being operated through the complete violation of national and international instruments in RMG sector. The factory workers are deprived of all legal benefits including payment of monthly wages, overtime, leisure, maternity leave, encashment of earn leave, bonus and even government declared minimum wages according to labour law.

Factually, a fabricated so called trade union in this factory was formed by the employer

earlier. Even the common workers don't know who the president/secretary or the office bearers are of the aforesaid union. Workers are not aware of the existence of the so-called union. Some of the general workers, on 15th October 2019 unanimously, agreed upon and submitted an application to the DoL, Chattogram to get a trade union

registration and it was rejected on 9th December 2019. On 17th December 2019, Raful Uddin, Secretary of the proposed trade union was forcefully denied to give access to enter the factory. On that very day, 8 other workers who were also with the unionizing effort were called by the factory management to give signature in blank/white paper. They denied doing so. Thus, a show-cause notice was issued to each of them and simultaneously, the notice was hung in the factory notice board the next day. However, the workers gave reply of the notice. On 13th February 2020 the workers further applied to DoL for TU registration after fulfilling the demand and removing the objection raised by the registration authority. Unfortunately, hearing the re-submission of TU registration application to the concerned authority on 15th February 2020, 8 female workers were called once again by the factory management and did ill behave and even physically assaulted in presence of BGMEA officials and Industrial Police personals present during that time On 16th February 2020 all 9 workers of Ritzy Apparels Limited including Rafuluddin and 8 other women were finally removed from job, even without following minimum procedure. As per sub-section 1 & 2 of Section 186 of Bangladesh Labour Law, management dismiss/terminate/remove worker from job while the trade union registration process is on.

This is to be mentioned that, after reporting all the ill-activities of the factory management to DoL/Registrar of TU, in an issued letter mentioned that the Ritzy Apparels Limited authority did unfair labour practices and anti-TU activities. This is a drastic example of frustrating trade union activities in RMG sector in Bangladesh. We have to stand together against such illegal steps of the employers at national and international level in support of victim RMG workers-the meeting decided.
