In the new project BILS will work on Worker Based Monitoring (WBM) part where **ESDO** will implement Community Based Monitoring (CBM) both interventions field level opeartional work will implement at Ashuila area.

Before April 2023, declaration of Minimum Wage Board for RMG workers wage fixation TU continued their movement and implement the campaign and mobilization activity at field level where core demand was to form the board and declare the new wage. As per SKOP & IBC leaderships suggestion BILS published the RMG wage



Workshop with Women Committee of IndustriALL Bangladesh Council

BILS organised a workshop with IBC Women Committee members with a view to sensitize ILO C-190 and discuss on gender gaps in legal framework; and identify on April 17, 2023 at BILS Seminar Hall. Kutub Uddin Ahmed, General Secretary-IBC & Member Advisory Council-BILS chaired the workshop. Md. Babul Azad, Acting Project Director, USAID's Women Thrive in Bangladesh Thrive Activity shared the Overview and CARE Contribution to ILO Convention 190 and Ms. Kohinoor Mahmood Kohinoor Mahmood, Director-BILS shared the Gaps in Existing Legal Framework Addressing GBVH in light of the mandates C-190. Kazi Rahima Akter Shathi, Member- BILS Executive Committee; Nasrin Akter Dina, Member, BILS Executive Committee and China Rahman, Women Affairs Secretary-IBC shared their expert opinion on the C-190, gender gaps in legal framework and role of

During the workshop three questions were given to the participants for their opinion, comments and recommendations and some workshop cards were given to write their opinion down. The workshop ended with a wrap up session of the discussion on the recommendations collected participants and they are as follows:

Recommendations from Meeting:

Role of Women Leaders of IBC

- IBC Women committee can organize different campaign on ILO C-190;
- IBC Women committee can organize women workers and make them aware of the C-190.

- IBC Women's Committee can form area-based women's committee for area-based action on different issue like raising awareness in C-190;
- IBC Women committee representatives can form women's committee for their own federation;
 - Different awareness raising activities could be done (like distributing leaflets on 'The Prevention of Oppression Against Women and Children Act, 2000', National International Day Celebrations etc.
 - Organizing yard meetings for raising awareness on C-190.

Necessary Action for Ratification of ILO Convention 190:

- Preparing an all-federation common position paper on the ratification of C-190;
- A memorandum can be submitted to govt. on the ratification of C-190;
- A press conference can be organized by IBC women's committee
- Organizing different campaign on the ratification on C-2190;

Expectation to BILS/Care Bangladesh (for the implementation of the recommendations mentioned above)

- Support for organizing campaign and raising awareness;
- Support for organizing tripartite discussion for the ratification of C-190;

The orientation meeting with Juri Valley committee leadership took place on May 9, 2023, aiming to orient the project goals, objectives, and activities and make recommendations from the valley-level

Valley, moderated the program. At the start of the program, Sri Komol Chandra Bunarji, Juri Valley. president of welcomed participants and guests to the meeting. He said. It is our pleasure that BILS has been implementing a project with the support of OXFAM in Bangladesh and the European Union to empower women workers in the garden sector in Juri, Longla, Monodholai, and Balishira Valley. He requested the leadership of the meeting's active participation in a more efficient implementation of the project activities. After the introductory speech of the chair, Ratan Kumar Pal, General Secretary of the Valley and moderator of the program, requested that participants introduce themselves one by one. After introduction, the moderator asked Monirul Kobir to outline the event objectives and the

We want our fair rights, we want to reach our destination, and we will stand up for the Tea Garden workers with our own skill and knowledge, she said in her speech at the meeting. mentioned we never fall again into

inequality; rather, we go forward. Then Rambhajon Koiri, a Prominent Tea worker Leader, former General Secretary and Executive Advisor of Bangladesh Cha Sramik Union, and Upazila Vice Chairman of Komol Gonj Upazila, said, BILS has been working for Tea Garden Workers with transparency. BILS works awareness and ensure the rights of the tea garden workers. He mentioned, Do earn the knowledge for the struggle and survival. Afterward, in the open discussion session, Sumon Ghosh, President, Ratna Tea Garden, said that Women tea garden workers are very vulnerable groups and are deprived of many basic rights due to their unconsciousness. He mentioned that BILS intervention will help the women tea garden workers build their capacity for future leadership, creating awareness. and determination to achieve their rights. Sojal Bauri, advisor to the Juri Valley Committee, said we need more participation of women tea garden workers in training, seminars, and other interventions that BILS will be doing in the Juri Valley. Mosber Ali, President of Shilura Tea Garden, mentioned

that I recognize the women workers' contribution to the because garden they fulfilling their responsibility through hard work. The women tea garden workers start their work at 8 a.m. and close at 6 to 7 p.m. daily, he briefed. Mohon Rickmun, President, Pathalia Tea Garden, requested to ensure the inclusion of women leaders of the panchayat committee in the BILS training program in the valley. After the open

discussion, the chair of the program said, We are very happy for your spontaneous participation and have provided some significant recommendations that will ensure the efficiency of our project intervention. He wishes for all kinds of support for the implementation of the project activities and closes the event by giving thanks again to all.

The key objective of the meeting was to share the project goal, objectives, activities, and expected results among valley the leadership and draw their recommendations the betterment of the project intervention. Sri Sanju Ghosh, General Secretary of the valley committee presided and moderated over the meeting. At the start of the program, the chair and moderator honored the participants, BILS, and OXFAM in Bangladesh. He mentioned we are very happy because we got an opportunity to enhance the women's leadership of the tea garden sector. 51 % of women exist among permanent workers and 60+% women among temporary workers in the tea garden sector. So, it is significantly justified to specific activities for women's leadership development in the tea garden sector in Bangladesh. He committed to all support kinds for the implementation of the project activities in longla valley. After that, he requested participants and guests to introduce themselves one by one. Then Monirul Kobir from BILS delivered the project purpose and detailed activities in the program and requested participants to their opinion and suggestions for the effective implementations of the project in longla valley. Manik lal bauri, President of Chanbagh tea garden suggested increasing the quantity of training and participation within the project budget and mentioned many garden-level leaders will manage the venue in the garden without venue rent. Kollyan Bunarji, a prominent panchayat leader of olichura tea garden said I think this program will help to enhance the women's leadership in the tea garden sector. He requested to expand the locations of the project. Afterward, Sudip koiri, General Secretary, Udali tea garden mentioned, it will a very significant initiative to capacitate women's leadership development in the tea garden sector and we will be ready to support BILS and OXFAM in Bangladesh in their interventions. Orientation workshop on BILS-Web Based System

Earlier, another Consultation Meeting with worker Representatives of the RMG Tripartite Consultative Council was held on May 21, 2023, at BILS Seminar Hall. In a meeting chaired by Nazma Yesmin, Director, BILS, Shajib Dey, Research Officer, BILS, presented the RMG wage research key findings and the study conducted by BILS. On May 9, 2023, the government formed a new wage board to review garment workers' minimum monthly wages from the existing Tk 8,000 fixed in 2018. According to the circular, Bangladesh National Garments Workers Employees League President Sirajul Islam Rony has been appointed workers' representatives for the wage board. The objective of this meeting was to share the study findings with Workers representatives and identify the missed opportunities for preparing the argument paper.

After an organized series of workshops with SKOP and IBC leadership, a Trade Union Position paper on Social protection for RMG Workers has been prepared and published. The TU position paper was also distributed among all SKOP and IBC federations for mass-level campaigns and awareness about workers social protection.

In the same way, an orientation workshop on the BILS-Web-Based System for Data Entry, Preservation, and Analysis was held on May 10, 2023, at the BILS Seminar Hall,

where all officials of BILS joined the workshop. This event aimed to orient the officials on MEAL, the data entry process, and analysis. All project information will be entered into the web-based system, and the progress and designated report will be updated accordingly.

Later, a draft Study Report sharing the effectiveness of the role played by the complaint committee to Protect Sexual

Acting Project Director, USAID's Women Thrive in Bangladesh, presented A Snapshot of ILO Convention 190 for a Conceptual Review. Kohinoor Mahmood, Director-BILS, has presented on 'Gaps in the Existing Legal Framework Addressing GBVH in Light of Mandates C-190'. Study Circle for Youth Trade Unionist



Study Circle

Bangladesh Institute of Labour Studies-BILS has been implementing a project to encompass leadership development in the Labour Rights movement in Bangladesh and the Academy of Work Courses. This project is supported by the Friedrich Ebert Apart from this Stiftung. project intervention BILS organizes study circles in different project locations on a regular basis. On 17 April 2023, a study circle took place at Dhaka Ahsania Mission, Dhaka. The Youth Trade Union member and leaderships are the core participants of this study circle.

Earlier, BILS had already organized the first study circle here. This was the follow-up round of the study circle. All the participants from different Trade Union Federations who joined the first programme also joined this one. Some participants were changed by the federations as the programme demands the youth group from the federations, so age is a significant consideration.

The study circle started with the opening session. In this session, Ahsan Habib Bulbul, General Secretary, SLF, Nazma Yesmin, Director, BILS, Iqbal Hossain, Programme Advisor, FES-BD, and Md. Meem Nur Hosain Turzo, Programme Officer, BILS, participated. The session included the entire study circle programme moderated by Nazma Yesmin, Director, BILS.

The programme started with the welcome remarks from Nazma Yesmin. She shared her greetings to all the participants and also her expectations from this programme. With this programme young Trade Union leaderships and members would get a scope to learn about the subject matters which is relevant to workers' rights. He also requested all the participants to have concentration to the session discussion and also share their thoughts regarding the discussion topic. In the earlier study circle BILS prepared a list of subject matters that the participants from Dhaka desires to learn.

From that list one topic has been finalized for this session. This year the Labour Law reformation process is ongoing and earlier Dhaka participants were interested to learn about this one. So, BILS decided to conduct a session on Bangladesh Labour Law 2006.

As Dhaka is surrounded by different industrial zone and huge numbers of workers are working in this area so youth Trade Union leadership from this area should have the knowledge of the Labour Law. In the opening session Ahsan Habib Bulbul also had some words. appreciated BILS and FES for their initiative. The youth Trade Union leadership from different sector has their field level experiences but they should also have some proper knowledge and learning from experts regarding different issues to Labour Market and Labour Rights. BILS has taken that initiative to share knowledge to the local level Trade Union members and leaderships. With this initiative in future the Trade Union movement would have some experienced leaderships.

Followed by Iqbal Hossain shared his words with the participants. He mentioned about the Academy of Work and its details. He describes the details about AoW and the enrollment process. AoW expects participants from these study circles. He

also shared that, with AoW this the participants would get huge access learning's those issues regarding to workers' rights. After that, Md. Meem Nur Hosain Turzo came up with the Objective & Context of the Program. In his discussion he mentioned about the background of the study circle. With this study circle the local level Trade Union

leadership and members will have better knowledge and understanding about different issues and subject matters relevant to labour rights. On the other hand among them which participants are capable off and interested to join the Academy of Work they will have the scope to join there. In every study circle BILS tries accommodate resource persons/ trainers from BILS trainer's pool who are very much acquainted with different labour issues and can easily connect with the participants. He also shared the further plan with the participants that this study circle will continue in future so, who have participated here they should continue in future.

Study Circle Discussion

The core session on the Bangladesh Labour Law Amendment 2018, conducted by Ahsan Habib Bulbul, shed light on;

- Labour Law Introduction and Functionality
- Collective Bargaining and Workers Protections
- ➤ Women Workers Rights and Maternity
- Occupational Health and Safety
- Social Security and Welfare Management

The session on the Bangladesh Labour Law 2006: Amendment 2018 was highly informative and provided valuable insights on the law's introduction and functionality. The resource person, Ahsan Habib Bulbul, delved into various aspects of the law, including collective bargaining and workers'

protections, women's workers' rights and maternity, occupational health and safety, social welfare and security and Through this two-hour management. participants gained session, a better understanding of the labour law and its for workers' implications rights and

protection. The session also highlighted the challenges faced by workers in the country and the need for better enforcement of the law to ensure their well-being. Overall, it was an insightful and thought-provoking session that left participants with a deeper appreciation of the importance of labour rights and protections in Bangladesh.

Later, resource person organized a group

work task for the participants. He divided the participants into four groups. Then asked them to discuss among them and write the key sections that a Trade Union member or local level leadership should learn at least.
